

Reply to Mr. Wold

Dear Mr. Wold

I received a reply from your District and I need to point out a few things:

The documentation provided has not been presented only in favor of Carlo Parlanti, but there are some reports for those individuals who violated the law. In the Penal Codes we can find:

- Penal Code Section 72, 118, 129
- Government Code Section 12650
- Penal Code Section 236-237 (false imprisonment and having not sent to Germany the evidences that could have led to a European defence, avoiding Carlo Parlanti's extradition).
- Penal Code Section 470, 483.5
- Penal Code 518-519

And we can find even more violations committed, like the aggravated fraud to the State.

On the website "<http://www.carloparlanti.com> you can now find three important audio recordings.

Concerning the email, you said that with that documentation I only provided opinions; as a matter of fact, I gave you some expert analysis and I would like to draw your attention on the fact that Dr. Pozzi is not, as you wrote, a "supposed expert", as she actually is a surgeon. And she's not the only one questioning the medical aspects, highlighted before and during the trial, and the related documents received by your District and that are supposed to be investigated. Dr. Pozzi's report has been supported by other doctors.

Among the important things, on the website <http://www.carloparlanti.com> you can find the recording of Mr. Romero admitting he didn't provide Germany with the evidences, so that he caused a fraudulent extradition. This is supporting the ID6 I report. The documentation written in German demonstrates that Germany asked your District for more evidences and documents, but the answer received was that there was nothing but a generic medical report and they also sent just a part of the accusation report.

The DA Gilbert Romero admits, in our conversation, that if the woman lied and presented false evidences then she'd be a criminal and criminals are legally prosecuted. Again, during my conversation with him it comes out pretty clear how he's actually not convinced of the photos' genuineness; and the photos' falsity can be easily proved. As I already told you, you'll receive other reports and documentation, but as you can hear from the recording the detective himself says that more investigations will be made.

I hope this is the same path you're following and I also hope to receive updates about the new investigations like, for instance, how long does it take to certificate the photos' falseness? Or if the diaries have been created ad hoc or if they existed in march 2002? Or if those specific physical assaults could have been possible and if Ms. White lied to damage Mr. Parlanti and the State?

Other important things we need to prove the size of Carlo's hand, you tell the doctor in Italy wrote still opinion, then, you need to try to insert in a vagina (7 cm) an object have Carlo's hand size, this is another from 10000 lied from Ms White, Mr Romero says if she

lied, she is a criminal.
